

## **Prepared Mind Tactics**

## Waiver and Release of Liability

I have come today to take part in firearms and firearms related training and I'm doing so of free mind and without coercion. I understand that firearms training can be dangerous and the risk of serious bodily injury and death are possible. The following are some of the injuries that could occur, these are examples and this list is not intended to represent every type of injury that could occur:

- Accidental shooting by self or other participant.
- Injury to self from mistakes in gun handling, such as injuries to fingers or thumbs from improper holding or operation of firearms, including but not limited to semi-automatic handguns with moving slides.
- Injury from "backsplash" of the target backstops. Such backsplash can
  include pieces of the projectile or of the backstop or other parts of range
  construction. Range rules require the wearing of eye protection and hearing
  protection, but the risk of backsplash burns or more serious injury from
  backsplash cannot be completely eliminated.
- Health effects associated with the inhalation of lead particles, lead fumes, powder residue, smoke, and other airborne matter.
- Hearing damage associated with the loud sound of a pistol or rifle report.
   Hearing protection is required of all participants, but total elimination of associated sounds can't reasonably be achieved.
- Damage to eyesight associated with shooting, including but not limited to entry of backsplash material into the eye.

I've been read, provided a copy of, and signed a copy of the Range Safety Rules and further understand that I'm required for my safety to follow all Instructor/s directions at all times.

This liability waiver is intended to be as broad and inclusive as is permitted by law. If any provision or part of any provision of this agreement is held to be invalid or legally unenforceable for any reason, the remainder of this agreement shall not be affected and shall remain valid and fully enforceable.

To the fullest extent allowed by law, the participant agrees to waive, discharge claims, and release from liability, and to indemnify and hold harmless Prepared Mind Tactics, It's instructors, anyone else serving on Prepared Mind Tactics authorized behalf, any business with any an associated business relationship, it's participants, and property owners / holders of range property / training location/s from any and all liability on account of, or in any way resulting from injuries, damages, wrongful death, loss of services, and or otherwise, even if caused by negligence of any of the above mentioned parties. The participant understands and intends that this assumption of risk and release is binding upon his/her heirs, executors, administrators and assigns, and includes any minors accompanying the participant.
